2007 ANNUAL MEETING REVIEW

The 2007 Annual Meeting was held on November 9th, at Hardin Hall on the University of Nebraska's East Campus in Lincoln.

Rock Krzycki with the city of Lincoln's Public Works Watershed Management Division led a series of presentations on Lincoln's NPDES Phase II compliance activities. Other presenters from the city of Lincoln, Lower Platte South NRD and Lancaster County included Ed Kouma, Nate Hartman, J.B. Dixon and Ben Higgins.

Following the presentations, a bus tour included visits to several rain gardens, watershed restoration projects, porous concrete demonstration projects, and a bio-swale to illustrate best management practices being implemented to support Lincoln's Stormwater Management Program.

Following the tour, an annual meeting was held to review current issues, identify possible topics of interest, and elect new officers for the upcoming year. Detailed meeting minutes are posted on the NeFSMA's website.

ARE YOU A CERTIFIED FLOODPLAIN MANAGER (CFM)? by Paul Woodward, P.E., CFM

The Nebraska Department of Natural Resources is a supporter of the Association of State Floodplain Managers. A part of that support includes encouraging individuals that work in fields related to floodplain management to train and test to become Certified Floodplain Managers (CFMs). NDNR, upon request, will schedule and proctor exams for individuals seeking this certification. A review session can be provided prior to taking the exam.

The ASFPM website, http://www.floods.org provides access to a study manual, in PDF format, covering the material that will be included in the exam. Applicants must schedule with and pay fees to ASFPM to take this exam. Please coordinate your interest in taking the exam with NDNR, to ensure that proctoring of the exam can be scheduled. In the past, the exam has been coordinated so several individuals can take the exam at one time. NDNR, upon request, will provide a CD copy of the training material. FLOODPLAIN MAPPING AND LEVEES by Paul Woodward, P.E., CFM

Have you ever wondered how floodplain mapping efforts in Nebraska, ongoing since 2000, would address existing levees? Well, up until 2007, so did everyone else; not just in Nebraska, but everyone in the nation. So what changed in 2007?

Actually, the story really begins with Hurricane Katrina in 2004. This single disaster left our nation asking questions not only about the levees protecting New Orleans, but all levees. Unfortunately, there was no one point of contact that had a complete inventory of all the nation's levees. Some are operated and maintained by the federal government, such as the U.S. Army Corps of Engineers (Corps), while others are simply managed by local farmers and towns.

Since the hurricane, the Corps and FEMA have worked together to address levees and other hazards. This cooperative program is known as the National Flood Risk Management Program. A lot of information about the program and the levee issues in general is available at:

The quandary is that as FEMA's Map Modernization effort continues, more and more levees must be accessed to determine if they can be certified for protection. Certification of a levee is a very involved process which requires that a professional engineer certify all the necessary documentation needed to show that the levee meets minimum federal criteria. This certification process has delayed the release of some maps and has complicated the production of almost all ongoing floodplain studies.

In response to these delays, FEMA has implemented a partial certification program in 2007 which affords a levee owner a period of 2 years with which to certify the levee. During the 2 year period, the levee is shown as providing protection to certain areas on the map; however, these areas are labeled with a "warning" that the levee is only partially certified and the map may have to be changed if the levee cannot meet the criteria.

So, how does this all affect ongoing efforts in Nebraska?

Let's use the small Village of Waterloo as an example. Waterloo sits along the banks of the Elkhorn River in Douglas County, Nebraska and is protected by a ring levee surrounding the town. Since there was no ongoing or proposed study on the Elkhorn River, everyone assumed the question, "does this levee protect against the 1% chance annual flood?", wouldn't come up. However, a change to the floodplain map in nearby Elkhorn just happened to occur in the same map panel as Waterloo and required that the levee be recertified. Since FEMA and the P-MRNRD, who had worked together for 4 years to prepare the new maps in Omaha and Elkhorn, didn't want to delay those maps. Waterloo was asked to sign a Partially-Accredited Levee (PAL) Agreement which would give them 2 years to determine if their levee meets the minimum standards. Waterloo signed this agreement in October and preliminary maps for the new study in Omaha and Elkhorn were issued on October 31, 2007. So, over the next 2 years, Waterloo will have to acquire existing information, resurvey, and likely hire an engineering firm to determine if their entire town will have to be shown in a floodplain or not.

The conclusion of this story is that this same scenario may occur in several towns around Nebraska as flood studies and maps are updated. For instance, a new study of the Missouri River may affect levees all the way from South Sioux City to St. Louis, MO.

We all need to be aware of the situation and spread the word to other local counties and towns who may be affected; and remember, the purpose of this endeavor is not to be mean and force people to buy flood insurance, the real purpose is to make sure everyone is aware of the true flood risk and that levees should not give a false sense of security!

NEW GENERAL CONSTRUCTION STORMWATER PERMIT ISSUED by Jesse Poore

The Nebraska Department of Environmental Quality has issued the long awaited NPDES General Construction Stormwater Permit. This Permit is effective as of January 1, 2008. A copy of the permit, fact sheet, and all application forms are located on the NDEQ website. Individuals may find it easier to find the documents that have been attached to the NeFSMA webpage www.nefsma.net

Please note that **within 90 days** (March 30, 2008) all active construction activity that was authorized under the previous general permit must apply for coverage under the terms of the new general permit. THE MOVEMENT TOWARD LOW IMPACT DEVELOPMENT by Jesse Poore

The Environmental Protection Agency (EPA) recently published a report that challenges engineers, planners, civic leaders, architects, and developers to consider ways to incorporate alternative stormwater management into our developments. The report, which is available online at http://www.epa.gov/owow/nps/lid/costs07/, argues that implementing Low Impact Development (LID) techniques can actually save money.

A paragraph from the article states "Low Impact Development (LID) is a stormwater management strategy that seeks to mitigate the impacts of increased runoff and stormwater pollution. LID comprises a set of site design approaches and small-scale stormwater management practices that promote the use of natural systems for infiltration, evapotranspiration, and reuse of rainwater. These practices can

effectively remove nutrients, pathogens, and metals from stormwater, and they reduce the volume and intensity of stormwater flows."

This report from EPA summarizes 17 development case studies that include various LID practices and concluded that "applying LID techniques can reduce project costs and improve environmental performance. In most cases, LID practices were shown to be both fiscally and environmentally beneficial for communities. In a few cases, LID project costs were higher than those for conventional stormwater management projects. However, in the vast majority of cases, significant savings were realized due to reduced costs for site grading and preparation, stormwater infrastructure, site paving, and landscaping.
